## MOLD REMEDIATION AND LEGAL LIABILITY

## A New Phase for the Industry and a New Approach to Dealing with It

The team at Wonder Makers has developed and refined a four-hour seminar entitled *Mold Science, Medical, and Legal Information* — *Connecting the Dots.* This detailed work was recently offered as a pre-conference seminar at the IAQA convention in Orlando. A primary piece of the presentation is that it is closely supported by an extensive collection of references – 51 studies, government documents, and reports that confirm the conclusion that we are again entering a time of increased mold risk. We received many positive comments about the seminar and the overall feedback on the reviews was extraordinary. It is clear that pulling the various studies together and presenting it in a comprehensive, understandable way is opening the eyes of many in our industry to the substantive changes that are again impacting mold remediation.

It appears that the pace of this change will continue to accelerate. A Fungal Research Group (FRG) meeting recently held in New Jersey focused on the response to mold resulting from Hurricane Sandy. The presentations there made it clear that medical data connecting mold to serious health effects keeps piling up.

The new information presented in *Connecting the Dots* is valuable for contractors, consultants, attorneys, and representative of the insurance industry, and their customers, clients, and colleagues would benefit from hearing this presentation, as well. The Fungal Research Group conference also highlighted the need for proactive approaches to preventing and remediating microbiological contamination. (As emphasized in the seminar, the health effects are clearly connected with water-damaged buildings [WDB], not just mold). Fortunately, the mold remediation industry (as well as fire/flood restoration) has found some transitional technology from the food service cleaning sector that is improving the speed and effectiveness of microbiological contamination cleanup. Wonder Maker's presentation at the FRG conference described the "Sandy Solution," a comprehensive approach with foam cleaning at its core. We have included the written summary for that presentation, which was shared as the

session abstract, on our website. The PowerPoint program from the conference is also available on our website. It is worth the time it takes to open it and especially focus on the center section where there is a description of foam cleaning.
